DEFAULTING INSTITUTIONS GIVEN FINAL NOTICE TO SUBMIT 2025 RTI ANNUAL REPORTS

The Right to Information Commission (the “Commission”) hereby publishes the names of **Ministries, Departments and Agencies (MDAs)** as well as **Metropolitan, Municipal and District Assemblies (MMDAs)** that have failed to submit their **2025 RTI Annual Reports** as required under the **Right to Information Act, 2019 (Act 989)**.

The institutions listed in this publication are in **breach of their statutory obligations under Section 77(1) of Act 989**.

The Commission hereby grants all institutions named in this publication a **final grace period of fourteen (14) days** from the date of this Notice to submit their outstanding reports.

Failure to comply within the stipulated **fourteen (14) day** period shall result in the imposition of **administrative penalties** and any **further enforcement action** permitted under law.

This publication serves as a **final notice** prior to the commencement of enforcement measures against defaulting institutions.

CONTENTS OF THE RTI ANNUAL REPORT

Pursuant to **Section 77(2) of Act 989**, and the updated reporting template issued by the Commission, each report shall include the following information:

 - g) The **number of applications sent to court for judicial review**, and the **outcomes**, if any.
 - h) The **average response time (in days)** for processing RTI applications.
 - i) The **average internal review response time**, (in days) for determining internal reviews, where applicable.
 - j) Any other relevant matters relating to the implementation of Act 989.
